### **Waiver of Liability (Please Read Before Signing)**

Parent/Guardian: I/we, the parents and/or legal guardians of the above-named child, hereby both freely and voluntarily give my/our consent and approval for participation in the martial arts program stated on this form, and further, agree individually and on behalf of my/our child, to the terms of the waiver, release, covenant not to sue and indemnity agreement as set forth herein below. In case of injury or illness, I/we give our consent to emergency transportation and the administration of any first aid, medical and/or dental treatment. I/we accept responsibility for the payment of any such emergency transportation and treatment expenses and any related or subsequent medical bills. I/we acknowledge that Vinh's Tae Kwon Do Family Fitness Center, Inc. (Hereinafter "VINHS") has not purchased and will not provide any medical, health, or accident insurance to cover such expenses and that any such insurance is my/our responsibility. I/we understand that there are inherent risks in the practice of martial arts, including physical injury. I/we, individually and in our capacity as parents or guardians of the above-named child, assume all risks and hazards incidental to such participation, including, but not limited to, physical injury and transportation to and from activities; and I/we hereby waive, release, absolve, indemnify and agree to hold harmless

VINH'S, the program instructors, sponsors, supervisors, participants, person(s) transporting my/our child, VINH'S members, officers, directors, employees, volunteers, agents or any other representatives of VINH'S, from and against any and all causes of action, claims, demands, losses, expenses or liability of any nature whatsoever, in law or in equity, arising from the activities contemplated hereby. In the same capacities, I/we covenant and agree not to sue VINH'S, its' instructors, sponsors, supervisors, participants, and person transporting my /our child, VINH'S members, officers, directors, employees, volunteers, agents or any other representatives of VINH'S, for any such causes of action, claims, demands, losses, expenses or liability. I/we understand that conduct by I/we, parent(s) or legal guardians, or by my child, deemed inconsistent with the rules of sportsmanship and fair play, could result in expulsion from VINH'S program.

### **Camp Waiver/Medical Authorization**

As the parent/guardian of the applicant, I hereby grant permission for him/her to participate in all camp activities with Vinh's Tae Kwon Do Family Fitness Center ("Vinh's) and represent he/she is physically able to participate in camp activities. In consideration of the applicant's being allowed to participate in the camp, thereby release Vinh's, its employees, officers and employees from all claims resulting from illness, injuries or other damage which may be sustained by the child during attendance at the camp. I furthermore agree and promise that we will not hold Vinh's or any of the above parties responsible in this respect. This waiver of liability expressly includes transportation to, from or in connection with such camp. I/We irrevocably consent to allow Vinh's Tae Kwon Do Family Fitness, Inc. to use, or consent to the use of, any likeness of my child in materials produced for school promotional or publicity purposes, without right of review.

### **AUTHORIZATION FOR MEDICAL AND SURGICAL CARE:**

If my child is injury in an accident or becomes seriously ill, and I or my designee cannot be reached, I authorize Vinh's Tae Kwon Do to arrange for the transportation of my child to a licensed emergency medical care facility to receive prompt treatment. Furthermore, I authorize the medical personnel at the facility to provide such treatment to my child as is indicated by the nature and extent of his or her injury and that is in accordance with the protocols of standard medical practice. Finally, I accept full financial responsibility, for all costs, charges, and fees associated with the transportation of my child and for the treatment provided by the medical care facility to my child and absolutely and unconditionally agree to indemnify and to hold Vinh's Tae Kwon Do harmless from all such costs, charges, and fees.

When I or emergency contact cannot be reached, I give my consent and permission for any licensed physician, dentist, hospital or other health care provider consent to perform emergency medical treatment at my expense as deemed necessary for the well-being of my child. This attention may include transportation to the nearest emergency room.

**Camp Policies:**

**1) Camp fees are due on the Friday before or the Monday of each Camp week.**
